The undersigned and on behalf of myself and any and all organizations with which I may be associated with and its members and participants (and as agent for any organization of which I may be associated and its members), assume any and all risk and any and all derivative claimants understand and hereby agree to hold the Santa Clara County Peace Officers Association, and their officers, board members, employees, heirs, successors, and assigns, free and harmless from any and all claims, and causes of action. Be it in nature of personal injury or otherwise by reason of the undersigned's use of the premises and facilities, including the following: picnic grounds, shelter, campground etc. at the facilities located off Booker Creek Rd. / Deerpath Rd. in the city of Saratoga, Ca. 95070.

Photo/Video Release, Parent/Guardian of Participant agrees that the Released Parties may use images and recordings, whether audio, visual, or both ("Photos and Videos"), of the Participant and / or Parent/Guardian, taken during the Event. The Released Parties have sole discretion to use these Photos and Videos to benefit and promote the Released Parties and/or the Event. Parent/Guardian hereby releases and discharges the Released Parties from any and all claims and demands arising out of or in connection with the use of the Photos and Videos, including without limitation any and all claims for libel or invasion of privacy.

In signing Hold Harmless Agreement the undersigned acknowledges that he/she has carefully read and understood this agreement. Furthermore , the undersigned understands that he/she is waiving any rights to file a law suit or initiate a claim procedure in respect to recovering for any personal injuries, property damages or losses sustained by the undersigned or a minor child under the undersigns care and or control. Further, the undersigned agrees that this agreement shall be binding upon and inure to the benefit of the parties hereto and their respective heirs, executors, administrators, legal representatives and successors, and assigns.
