Members enjoy the use of our 177-acre private campgrounds, hidden among the redwoods, off Highway 9 above the City of Saratoga. These campgrounds feature 9 canvas tent cabins with wood floors, picnic tables, barbecue pits, restrooms with showers, potable water, hiking trails, pistol range and an archery range.



PISTOL RANGE

Safely tucked away above the campgrounds is our outdoor **PISTOL** range featuring eight shooting lanes with covered bench rests at the 50-yard line.



ARCHERY RANGE

Another area nestled above our campground is an archery range. There are two boxed targets with markings up to 25 yards.



CAMPGROUND AREA

Within the campground, we have a "kids castle" playground, swings, horseshoe pits, and a campfire amphitheater.



The campground area, **PISTOL** range, and archery range are available for your use year-round and are secured behind a locked gate with member-only access.
